8. COOKIES

On our website longtermgames.pl we use cookies and similar technologies (e.g. pixel tags).

Cookies are small packets of information saved on end devices, usually containing the website address, date of placement, expiry date, unique number and additional information in accordance with the purpose of the file.

The cookies we use can be divided into 3 categories:

- <u>statistical and analytical files</u> that allow us to understand how users behave on our website using aggregated and anonymous statistical information;
